Item No. 96.01 Confirmation of the minutes of the meeting of the Syndicate held on 4—2—1978.

Resolved that the Minutes of the Meeting of the Syndicate held on 4-2-1978 be confirmed.

Arising out of the minutes the Syn8icate reconsidered the first resolution under Item No. 93.24 (as amended at the meeting held on 4—2—1978) and Resolved that the matter be enquired into before ratification is made.

Item No. 96.02 Report by the Vice Chancellor on important developments in the University since the last meeting.

- i) With regard to the Trichur Engineering College, it is understood that the Government have taken a decision to re-transfer the College to the Government. Official communication is awaited. Payments have been made for the month of February 1978 (beyond 24—2—1978) after consulting Secretary to Governments, Higher Education.
- ii) The Vice Chancellor visited the UGC Office and had discussions with the Officers. It is likely that the University would get more funds from the UGC. The UGC suggested that a UGC Unit to deal with the UGC matters might be established and the UGC would give 100% grant for such a unit subject to a maximum of Rs. 12,000/-Officer and one Assistant.
- iii) The UGC would consider the sanctioning of grant for the buildings for non-resident students home, Students Union, and Employment Information and Guidance Bureau. Reasonable adjustments within the total Plan outlay may be possible.

- lv) The UGC might also consider waiving the student strength of 15000 for grant for gymnasium.
- v) The teaching posts for the second phase during the fifth five year plan period are likely to be approved if the question is taken up with the UGC.
- vi) The State Minister for Transport visited the Hill Palace Campus on 12-2-1978 and had discussions with the VC and other officers about the taking over of the Hill Palace by government for development of Tourism, Museum etc. The VC has suggested an adhoc grant of Rs. 50 lakhs for providing alternate facilities in the Thrikkakara Câmpus as well as the acquisition of 10-15 hectares of adjoining land.
- vii) Mr. D. Venzlaff, Consul General for FRG in Madras, visited the University on 26—2—1978 and presented a set of books and audio visual^r equipment.
- viii) In the afternoon there would be a Sports Award Day in which the Merit certificates would be distributed to the students who came out successful in the sports meet.

Item No. 96.03 Department of Industrial Fisheries—Arrangement of gust lectures and practicals.

The Syndicate considered the proposal of the Head of the Department of Industrial Fisheries for appointment of guest lectures for the conduct of IInd Semester of M. Sc. course in Industrial Fisheries, along with the recommendation of the Standing Committee on Academic Matters.

Resolved that the following guest lecturers be engaged for the second semester of M. Sc. course in Industrial Fisheries and that they be paid remuneration at Rs. 40/-per hour of lecture/per session of practical.

Resolved to clarify that the members of the University Authorities who are attending meetings of the Committees constituted by the Authorities concerned would be eligible for the higher rate of DA of Rs. 35/-

Resolved further that the VC and the PVC be entitled to draw DA at the rate of Rs. 35/- for Journeyes performed by them.

The Syndicate considered the recommendation of the State Co-ordination Committee for Vocational Guidance and the request of the Director of Employment Directorate of National Employment Service for making available to the University Employment information & Guidance Bureau a sum of Rs. 5000/- for the purchase of Books & Periodicals and other guidance activities along with the recommendation of the Standing Committee on Finance, Works & Purchase.

Resolved that the Vice Chancellor be authorised to sanction a suitable grant subject to availability of funds. after discussion with the Chief and Deputy Chief of the University Employment Information and Guidance Bureau.

Item No. 96.15. Construction of 2 Nos. of 'E. type staff quarters at Thrikkakara - Non-Completion of work by M/S. Mather & Co. contractors—Termination of contract and arranging of balance Work.

The Syndicate considered the proposal for the termination of the contract between M/s. Mather & Co. Ernakulam and the University for the construction of 2 Nos. of 'E' type staff quarters and for paying the contractor the cost of work carried out and releasing the EMD and the retention amount, along with the recommendation of the Standing Committee on Finance, Works & Purchase.

After a detailed discussion on all aspects of the case and also in view of the probable time lag involved if legal action is initiated and considering the further deterioration that would occur on the construction already put up, Resolved that:

- 1) As agreed to by the contractors M/s. Mather & Co. Pvt. Ltd, Ernakulam, they be paid for the works done at the original rates without any penalty.
 - 2) The EMD and the Retention amount be released; and
- 3) The matter be closed accordingly after getting all the necessary agreement executed by the contractor.
