Before taking up the Agenda, the Vice-Chancellor introduced the two new Syndicate members Dr. K. Parameswaran Nair and Dr. K. P. Balakrishnan and welcomed them.

Prising out of the minutes for the meeting of the Syndicate held on 4-3-1978, Dr. C. V. Kurian pointed out that he had placed his report about the installation of the telephone PBX and PMB System as required under the Syndicate held on 4-2-1978.

Sri. V. Narayanan Navar pointed and the Syndicate held on 4-2-1978.

Sri. V. Narayanan Nayar pointed out that he too had submitted the leave rules of the teachers for consideration by the Syndicate.

Minutes for 9-3-1978

Item No. 97.04.

The amount of Rs. 1.5 lakhs shown against the State Bank of Travancore, Trikkakara Branch be replaced by Ernakulam Rs. 05 lakhs" be deleted.

Arising out of the Syndicate decision under Item No. 97.26 dated 9-3-1978 regarding appointment of paper setters/examiners, Dr. K. P. Balakrishnan wanted a clarification regarding the procedure adopted for the appointment of paper setters examiners. The present procedure was explained by the Vice-Chancellor. In the light of the discussion that ensued it was agreed that a special meeting of the standing Committee of the Syndicate on "Academic Matters" be convened for study of the procedure for the conduct of the examinations and to suggest changes, if any, required.

Before taking up the consideration of the next items on the Agenda, the Vice-Chancellor suggested that Dr. N. Parameswaran Nair and Dr. K. P. Balakrishnan might be coopted to the Standing Committee of the Syndicate on "Academic Matters" and the Syndicate agreed to the suggestion.

It was also suggested that a Planning Committee of the Syndicate with one nominee from each of the Syndicate Committees be constituted for guiding the formulation and implementation of plan schemes in the University. Resolved that a Planning Committee consisting of the following members be constituted:

Item No. 98.02. Report by the Vice-Chancellor on important developments in the University since the last meeting

The Vice-Chancellor reported:

1) In the Fifth Convocation held on 29-3-78, 63 candidates were given degrees in person and 102 candidates n absentoa.

In this cennection the Vice-Chancellor reported that hereafter intimation about the Convocation would be sent to all the candidates eligible for degrees sufficiently early so as to avoid any complaint about the non receipt of the information about the Convocation.

- 2) The Vice-Chancellor attended a Conference for the preparation of a national paper for the U. N. Conference on Science & Technology at Bangalore convened by the Science & Technology Department of the Government.
- 3) The Vice-Chancellor visited New Delhi to attend a U. G. C. Panel meeting. He also discusses the University affairs with the UGC Officers and, as reported earlier, the Officers stressed that a UGC Unit should be set up immediately. The Vice-Chancellor also visited I. I. T., Madras and discussed with the Director and Others about the Ship Technology course and the possible assistance that we could get for the practical training of our students.
- 4) The Vice-Chancellor presented the terms and conditions of his appointment ordered by the Chancellor and he requested that his lien during the period of his appointment as Vice-Chancellor might be retained in the School of Management Studies.

Tha Syndicate resolved that the lien of Dr. M. V. Pylee be retained as the Director of the School of Management Studies during his period of appointment as the Vice-Chancellor of this University.

5) The Vice-Chancellor also reported about an unhappy incident that took place on 12-4-1978 in the University Library when the University Librarian was almost under Gheravo by a section of the lower grade employees. He reported that the Syndicate members Sri. V. Narayanan Nayar and Dr. N. Parameswaran Nair were requested to negotiate with the employees and settle the dispute. Accordingly they settled the dispute and gave the employees an assurance that the matter would be placed before the next meeting

of the Syndicate to be held on 15-4-1978. The Vice-Chancellor also reported that some damage had been caused to the telephone connection to the Library and flower pots and that the 4 tyres of the car of the Librarian had been deflated.

After detailed discussion, the Syndicate resolved that a special Committee consisting of the following members be constituted to enquire into and report on the problems facing the University Library including that of the staff.
