Item No. 142.01. Confirmation of the minutes of the meeting of the Syndicate held on 5/6-9-1980.

Resolved that the minutes of the meeting of the Syndicate

held on 5/6-9-1980 be confirmed subject to the following emendations.

a) Annexure I to item No. 141.06 - Vijayabalan. V., be deleted from the list.

b) Item No. 141.55 (iii) be emended to read "One additional Junior Research Fellowship be created for each of the Departments of Study and Research in the University and proposals regarding the same be placed before the next meeting of the Statutory Finance Committee."

c) Item No. 141.55 (iv) be emended to read as "In addition to (iii) above, two Junior Research Fellowships be created for the Department of Polymer Science and Rubber Technology and proposals regarding the same be placed before the next meeting of the Statutory Finance Committee."

Item No. 142.02. Report of the Vice-Chancellor on important developments in the University since the last meeting and items directly presented by him.

i) The Ship Technology students are very much concerned about the non-appointment of a suitable hand as Head of the Department of Ship Technology and it is unfortunate that they had resorted to agitational tactics inspite of the University's best efforts to find a solution to the problem.

Prof. J. P. Kundu, an Associate Professor at I. I. T. Kharagpur has been identified as a suitable person for appointment as Head of the Department of Ship Technology, and he has indicated willingness to join the Department if he is offered a regular appointment. But he would be

available only by June 1981. In view of this and the urgency of the matter, the Director of the NPOL, Cochin, has been requested to spare the services of Dr. P. D. Joseph, S. S. O. I, NPOL - he has been engaging classes for the Ship Technology students as a guest lecturer - for an year on deputation to work in the Department of Ship Technology. The Director has agreed to make the services of Dr. P. D. Joseph available to the University.

ii) A High power delegation of 4 from GDR headed by Prof. (Dr.) Engel, Deputy Minister, Higher & Technical Education, is arriving at Cochin on the 18th for discussions on extending the areas of collaboration between the Cochin University and similar institutions in GDR with particular emphasis on the starting of a course in Printing Technology at the University.

It would seem appropriate to have the new Ship Technology building formally inaugurated on the occasion of the delegation's visit. The University would play host to the GDR Delegation

iii) A welcome news has been received from the Rector, University of Rostock. The Rector has informed us that the services of Prof. Wiebeck would be available to the University until November 1981 and that of Prof. Stovehase until December 1982.

iv) The vacant posts in the Department of Ship Technology have already been advertised, and a Board of Appointment will have to be constituted to make the selections.

The Syndicate authorised the Vice-Chancellor to constitute the Board of Appointment for the purpose.

v) A reasonably good second hand bus (BENZ model) has been selected from the KSRTC's depot at Trivandrum. The bus would cost approximately Rs. 22,000/-. It is anticipated that the bus could be reconditioned and put to use within two months. The cost of the repairs is estimated at Rs. 20,000/-.

**ORDER**

At present pension of State Government employees is calculated at the rate of  $n/80$ th of average emoluments 'n' being the No. of years of qualifying service and the rate of full pension is  $33/80$ th of average emoluments subject to a maximum of Rs. 900 per month. The Government of India, in their O. M. read above have liberalised their pension formula with effect from 31-3-1979 by determining the amount of pension in accordance with the respective slabs specified in the O. M.

2. Government are pleased to issue orders introducing the above slab system adopted by the Government of India, under the State Government Rules also and determining the amount of pension in respect of State Government

employees accordingly with effect from 31-3-1979. In respect of the Government servants who were in service on the 31st March 1979 and retired / retiring from service on or after that date, the amount of pension shall therefore be determined in accordance with the following slabs.

3. The amount of pension arrived at on the basis of the above slabs will be related to a maximum qualifying service of 33 years. For Government servants, who at the time of retirement, have rendered qualifying service of ten years or more but less than 33 years the amount of their pension will be such proportion of the maximum admissible pension as the qualifying service rendered by them bears to the maximum qualifying service of 33 years. A few illustrations in this respect are given in the Annexure.

4. The rate of Death-cum-Retirement Gratuity ordered in the G. O. read as first paper above will remain unaltered.

5. All Pension sanctioning authorities will process the pension papers of those who retired on the A. N. of 31-3-1979 and afterwards in accordance with these orders and send pension cases to the Accountant General immediately.

6. Necessary amendments to the rules in Part III, K. S. Rs. will be issued separately.

If, however, the number of such cases/applicant are more than the vacancies, the Fellowship Committee may decide looking into the different aspects:

The Committee noted the decision of the Syndicate meeting held on 22.12.1979 in item No. 130.65 that applicants who were enjoying University Fellowships earlier (either of the department itself or transferred from some other departments for one year) may be ranked above new applicants.

Committee considered the merit lists prepared by the Heads of departments on the basis of new Career Analysis Index in respect of applications received prior to 16.8.1980.
