Item No. I58.01: Confirmation of the Minutes of the I57th meeting of the Syndicate held on 23-I0-I98I.

Resolved that the minutes of the 157th meeting of the Syndicate be confirmed subject to the following emendations

- i. Item No. 157.02, (iii), Commodore P. A. Menon be corrected as "Air Commodore P. A. Menon".
- ii. Item No, 157.03: 2(b) be substituted by the following recording: "The lists of selected candidates published by the University shall remain in force for a minimum

- period of one year provided that the said lists avill continue to be in force till the publication of new lists after the expiry of the minimum period of one year or till the expiry of two years whichever is earlier".
- iii. 157.03: 4 (i). The words "and appointments made consistent with the prevalent practice," be added to the sentence after University Service".
- iv. 157.03: 6 be deleted
- v. 157.14. The following sentence be added to the third paragraph: "This may be reviewed after one year".
- Item No. 158.02: Report of the Vice-Chancellor on important developments in the University since the last meeting of the Syndicate.
  - i. Dr. C. S. Jha who had been invited to join the Expert Committee has politely declined the invitation.
- ii. Some teachers of the Department of Marine Sciences had represented that a specialist in the field of Marine Sciences be included in the Expert Committee so that the developmental needs of the Department might receive better attention.

Arising out of it the Syndicate resolved that Dr. P. N. Ganapati, Emeritus Professor, Andhra University Zoology Department. Vizhakapatnam-3 be invited to become a member of the Expert Committee.

iii. The Syndicate at its meeting held on 15-4-1978 had resolved that Dr. M. V. Pylee be permitted to retain his lien as Director, School of Management Studies,

during the period of his appointment as Vice-Chancellor of the University. Eventhough his actual date of retirement would fall only on 31-10 1982, he had already reported his intention to voluntarily retire from University service w. e. f. the A. N. of 8,12,1981. He may therefore be exempted from the formality of reporting for duty as Director of the School of Management Studies on relinquishment of his present office as Vice-Chancellor of the University.

The Syndicate considered the matter and resolved that Dr. M. V. Pylee be exempted from the rule requiring him to report for duty as Director, School of Management Studies, on 9-12-1981 F. N., on relinquishment of his office as Vice-Chancellor, and that he be permitted to voluntarily retire from University service w. e. f. A. N. of 8-12-1981 as Director and that his pension claims settled accordingly.

Item No. 158.03: Departmental Council - Draft Rules - Consideration of -

The Syndicate considered the draft rules for the Departmental Councils contemplated under Statute 226 of the First Statutes 1980, prepared by the Committee of the Syndicate consisting of Dr. K. I. Vasu Dr. M. P. Parameswaran and Prof. P. S. Velayudhan, along with the recommendation of the Standing Committee on Academic Matters.

Resolved that Departmental Councils be constituted for each department of study or school of studies under the University and that their functions be regulated by the Rules as in Appendix 1.

Item No. 158.04: Upgradation of the posts of Teaching
Assistant held by Shri Oommen
Mathew and Smt. S. Sarada to the
post of Lecturer - Consideration of -

The Syndicate considered the proposal for upgrading the posts of Teaching Assistant in the School of Management Studies held by Shri Oommen Mathew and Smt S. Sarada to that of Lecturer for giving them norms promotion and the question of constituting a committee similar in composition to a Board of Appointment for assessing their suitability for the post of Lecturer, along with the recommendation of the Standing Committee on Academic Matters.

Resolved that a Committee similar in composition to that of a Board of Appointment be constituted for assessing the suitability of Shri Oommen Mathew and Smt. S. Sarada for the post of Lecturer. Resolved further that the Vice-Chancellor be authorised to choose an external expert from the panel of experts prepared by the Board of Studies in Management Studies, for inclusion in the Committee.

Resolved further that the post of Teaching Assistant be abolished once the present incumbents in that post leave the service.

Resolved also that hereafter no recruitment be made to the posts of Teaching Assistant and Research Assistant.

Resolved that the Kerala State Engineering Service Rules (General Branch) as regards qualifications and method of recruitment be followed in the University in making appointment to the post of Assistant Executive Engineer, except observance of the ratio as between degree holders

and diploma holders in view of the fewer posts in the cadre available in the Engineering Unit of the University.

Item No. 158.15. Appointment of Visiting Professor in the Department of Mathematics & Statistics-Dr. Peter Blanksby of Adelaide University, Australia-Consideration of-

The Syndicate considered the proposal of the Head of the Department of Mathematics and Statistics for appointing Dr. Peter Blanksby, Senior Lecturer, University of Adelaide, South Australia, as Visiting Professor of the Department for a period of four months from January 1982 to May 1982, along with the recommendation of the Standing Committees of the Syndicate on Staff and Establishment and on Academic Matters.

Resolved that Dr. Peter Blanksby be appointed as Visiting Professor for a period of four months from January 1982 to May 1982 under the UGC Scheme of Visiting appointment.

Resolved further that the Head of the Department be authorised to make the necessary arrangements for Dr. Blanksby's stay at Cochin, on his behalf.

# Item No. 158.17: Clerical Assistants promotion to the posts regarding.

The Syndicate considered the question of providing promotional opportunity to Class IV employees who have acquired SSLC qualification before their entry into Universits service in the context of the Syndicate decision under Item 141.30 dated September 5/6, 1980 fixing the normy for the promotion of Class IV employees as Clerical Assistants along with the report of the Vice-Chancellor in the matter.

Resolved that the following proviso be added to the Syndicate resolution under Item 141:30 dated September 5/6. 1980.

"Provided, however, such Class IV Employees as have joined University service with SSLC qualification may also be given promotion as Clerical Assistant in the ratio of 1:1 as between those who acquired the said qualification after entry into service and those who entered the University service with SSLC. The ratio be deemed to have been operative with effect from the date of decision by the Syndicate as per Item No. 141 30"

## Resolved further:

- i. The next vacancy to arise in the post of Clerical Assistant be given to the seniormost candidate who entered the University service with S.S.L.C.
- .ii Hereafter candidates with SSLC qualification shall not be recruited to Class IV posts in the University service. Dr.M.P.Parameswaran dissented from the above decision.

## APPENDIX I To Item No. 158.03

## Rules for the working of Departmental Councils

#### **Objectives**

The object of the Departmental Councils is to provide a forum for the faculty of each Department of study or School of studies to meet at regular intervals, share information and exchange views about the working of the department and ensure a sense of participation in its present and future activities.

#### Rules

- a Each Department of study or School of Studies shall have a Departmental Council, consisting of all its teachers.
- b. The Departmental Council will meet once a month or more frequently, if found necessary.

The Head of the Department shall, however, on a written requisition by not less than 1/3 of the total members of the Departmental Council, summon a special meeting, as soon as possible, for consideration of any matter specifically indicated in such requisition.

- c. The Head of the department shall chair the meeting of the Departmental Council of which he shall also be the Convenor.
- d. The Head of the Department will place before the Departmental Council all important matters relating to the academic and administrative work of the department and members shall be free to elicit information on

such matters and ask for a discussion on any aspect of the working of the Department

- e. The Departmental Council shall, in particular, discuss the following:
  - i. Budget
  - ii. Distribution and allocation of teaching and other academic and administrative work in the Department.
  - iii Development plans of the Department and in particulra its teaching and research plans.
- f. A copy of the Minutes of the meeting of the Departmental Council shall be forwarded to the Registrar as soon as may be.
- g. Teachers shall attend the meetings of the Departmental Council as a matter of duty.
- h. The work of the Departmental Councils shall be reviewed by the Syndicate after a year of their constitution.

#### APPENDIX II

## To Item No. 158.17

Note of dissent on the decision taken by the Syndicate held on 12-11-1981 on agenda Item No.17.

The Syndicate in its meeting held on 5-6-1980 made a decision that thenceforth the promotion of Class IV employees to the post of Clerical Assistants will be made only from among those who have obtained SSLC qualification after joining service. This was contrary to the practice followed till then.

The Staff and Establishment Committee in its meeting held on 3-7-1981 considered this issue and suggested:

"While making the decision on the 6th September 1,980 the Syndicate, at the instance of the Committee, has come to the conclusion that promotion need be given to those people who passed SSLC examination during the course of their employment in the University and not to those employees who have passed the SSLC examination prior to their recruitment. This appears to be apparently wrong and the Committee recommend that it should be rectified ".

The decision taken by the Syndicate held on 12-11-81 to modify the decision on the 6th September 1980 by giving alternate promotion to those who have passed earlier and those who have passed after entry to University does not rectify the earlier mistake.

I am of the opinion that all those who are presently in service and possess SSLC qualification should be given promotion strictly according to seniority, irrespective of when they have acquired the qualification before afterjoining service. This should be applied to all the existing staff. Henceforth admission to Class IV service should be restricted to those whose qualification is below SSLC.
