Item No. 173.01. Confirmation of the minutes of the 172nd meeting of the Syndicate held on 4-12-1982.

Resolved that the minutes of the 172nd meeting of the Syndicate held on 4-12-1982 be confirmed, subject to the following emendations/corrections:

(i) Item 172.02: 3rd line in para immediately following point No. 5. - the word 'Hindi' be inserted after 'third semester' and before 'supplementary examination.'

- (ii) Item No. 172.03: The last paragraph be emended to read as follows: "The Syndicate noted that the posts of Dy. Registrars are interchangeable as are the posts of Asst. Registrars, inter se."
- (iii) Item No. 172.08: the date of effect of the decision be indicated as 1-1-1983.
- (iv) Item No. 172.20: The resolution be emended to read as follows: "Resolved that a Committee consisting of the Pro-Vice-Chancellor, Dr. K. Gopalakrishnan Nair and Dr. K. Sathianandan may discuss the matter with the Heads of the Departments of Electronics and Ship Technology and propose a solution without prejudice to the interest of the students concerned."
- Item No. 173.02. Report of the Vice-Chancellor on important developments in the University since the last meeting.
- 1. His Excellency Shri P. Ramachandran, Governor/Chancellor and the Hon'ble Revenue Minister Shri P. J. Joseph visited the University on December 20, 1982 in connection with the function arranged to lay the foundation stone of the proposed School of Engineering Sciences.
- 2. The Vice-Chancellor and the Pro-Vice-Chancellor met the Vice-Chairman, the Secretary and other members of the State Planning Board at Ernakulam and had discussions with them on the further development of the University.
- 3. The Sixth Plan UGC Visiting Committee would visit the University during January 20-22, 1983. The UGC's Expert Committee on MBA Correspondence Course would visit the University on January 24, 1983.

- 4. As desired by the Syndicate the Vice-Chancellor had discussions with Shri V. Narayanan Nayar, Director of the School of Continuing Education. Shri Nayar has agreed to cut short his leave and resume duty when the University reopens after Christmas Holidays..
- 5. The Expert Committee constituted to formulate a plan and a strategy for the further development of the Uniquersity as the Science and Technology University of Kerala has formally submitted its report. Advance copies of the Report have been made available to the Planning Board and others concerned. Copies of the Report are being made available to all members of the Syndicate. The Syndicate could formulate its views and comments on the report at the February meeting of the Syndicate.
- 6. Based on the guidelines prescribed by the Committee constituted for the purpose, the Librarian has finalised the list of foreign periodicals to be subscribed to during, 1983. The said list is placed on the table.

Item No. 173.03. Employment Assistance to the son of late Dr. K. Nanukuttan Nair, Professor, S. M. S. - Regarding.

The Syndicate considered, along with the recommendation of the Standing Committee on Staff & Establishment, the request of Smt. Retnamma Nair, wife of the late Dr. K. Narukuttan Nair, Professor, of School of Management Studies, that their son Shri N. Steekumar be given employment in the University under the scheme of "Employment assistance to relatives of public servants dying in harness."

Resolved that Shri N. Sreekumar, the eldest son of late Dr. Nanukuttan Nair be given appointment to a suitable post.

- (iii) Payment be made in 8 stages, in amounts to be determined on the basis of actual measurements check-measurements of work done at site.

In respect of construction work of the present women's hostel, resolved that the work be entrusted with the KSCC Ltd., at a negotiated rate of not more than the estimate based on the 1980 schedule of rates plus 50% thereon.

2. No. PRI/GI/6-44/81-82/356 dated 3-3-1982 from the Accountant General.

ORDER

State Government pensioners re-employed under the Government/Public Sector undertakings are not eligible for dearness allowance on pension during the period of re-employment. According to the amendment made to the rules in Kerala Treasury Code by G. O. (P) 568/79/Fin. dated 28-5-1959, the requirement of furnishing non-employment certificates by service pensioners has been dispensed with. Moreover the pension disbursing officer (Treasury Officer) has no means to verify the correctness or otherwise of the certificate of non-employment, even if furnished by the pensioner. The responsibility of safe-guarding against double payment in respect of dearness allowance (both on pension and on re-employment pay) has therefore to be vested with the employer i. e., the concerned State Government Department/Public Sector Undertaking.

2. Accordingly Government are pleased to issue the following orders:-

D

- (i) Reemployed pensioners will be allowed to draw full Dearness Allowance along with the pension.
- (ii) The employer (the concerned Government Department/ Public Sector Undertaking) will deduct the amount of Dearness Allowance so drawn from the total remuneration payable to the pensioner on re-employment-
- 3. The Public Sector Undertakings/Corporations etc. may ascertain the rate of pension and dearness allowance/temporary increases received by the re-employed pensioners and refer to the office of the Accountant General, cases in which any clarification is considered necessary.
- 4. These orders will come into force with effect from 1-10-1982.

APPENDIX IV TO ITEM NO. 173.08

RULES FOR THE ADMISSION AND ACCOMMODATION OF STUDENTS TO UNIVERSITY HOSTELS

1.00 Admission

- 1.01 Admission to the University Hostels shall be open to full-time regular students admitted to a course of study of not less than two semesters and full-time research students. Fellows working in sponsored research, schemes in the University are also eligible for admission. A full time student who is employed but not in receipt of salary during the period of study is also eligible for hostel accommodation. But, full-time students under 'Faculty Improvement Programme' drawing regular salary from their parent institutions shall not be eligible for hostel accommodation.
- 1.02 Application for admission to the hostel shall be made in the prescribed form (Form A) in duplicate.
- 1.03 Admissions to Hostels are made by the Hon. Warden, on the recommendation of the Heads of Departments, normally at the beginning of the course or research work. While recommending accommodation, the Head of the Department will ensure that priority is given to those students whose normal place of residence is not less than 15 Kilometres away from the Campus except in the case of SC/ST and Physically handicapped students.
- 1.04 Priority in admission to hostel shall be given to SC/ST and physically handicapped students and foreign students.

- 1.05 Accommodation in the hostel shall be limited to the duration of the course for which a student is admitted and he shall be required to vacate the hostel within 7 days of his/her taking the last written/practical/viva voce examination of the regular course. One is not eligible for accommodation in the hostel for taking supplementary examination or viva voce examination.
- 1.06 A student admitted to an M. Phil. programme shall not be allowed accommodation beyond a period of 12 months.
- 1.07 A student admitted to research for Ph. D. shall ordinarily be allowed accommodation only for a period of 4 years. However, in the event of a scholar submitting the thesis earlier, he shall not be eligible to stay in the hostel beyond one week of submission of thesis.
 - Note: Occupants who have been in residence for more than 4 years as on 1-1-1983 shall vacate the hostel within six months, ie., on or before 30-6-1983.
- 1.08 If a hosteler after completing, the full-time course gets himself enrolled for another full-time course, his application for admission to the hostel shall be treated as a fresh one and he shall not be entitled to any preference by virtue of his earlier residence in the hostel.
- 1.09 Fees payable to the Hostel at the time of fresh admission as shown in Section 4 below shall be payable in the concerned departments on production of form A in duplicate duly endorsed by the Hon.

Warden. All subsequent payments of hostel dues shall be made monthly in the concerned departments.

- 1.10 On surrendering one copy of the hostel fee receipt in the hostel office and submitting the Form A duly filled in the student may be allotted a seat.
- 1.11 On allotting the room the student has to fill in Form B, a declaration, stating that he/she is jointly and severally responsible for the furniture and fixtures in the room and the hostel.
- 1.12 The Heads of Departments shall maintain a separate list of students recommended for hostel accommodation and inform the Hostel office the last date of the written / practical / viva voce examination of the final semester regular course at least 15 days in advance. And students shall be permitted to take the examination only on the production of NO DUES CERTIFICATE from the hostel, each semester. In the final semester they shall be required to fill in the Form C (the Application for refund of caution deposit) also to obtain the No Dues Certificate from the hostel.
- 2.00 Study Time.
- 2.01 Silence should be observed during the study time.
- 2.02 Inmates of Men's hostels are expected to be back in their rooms not later than 10.30 p.m. each day. Those who return to the hostel after 10.30 p.m. shall enter their names and room numbers in LATE-COMERS Register maintained in the Hostel. Research scholars may be permitted to stay late in the Library / Laboratory with the specific sanction of the Assistant Wardens concerned.

Note: Separate rules regarding discipline will be framed by the Hon. Warden in consultation with the Matron in respect of Ladies Hostel.

- 3.00 Visitors and guests.
- 3.01 Visitors shall not be entertained in the rooms during the study time and at night.
- 3.02 Guests may be allowed on sanction from the Assistant Warden and on advance payment of guest charges as per the hostel rules.
- 4.00 Fees and Charges
- 4.01 Caution Deposit Rs. 100.00
- 4.02 Admission fee Rs. 10.00
- 4.03 Association Fee Rs. 10.00 per semester
- 4.04 Room Rent Rs. 15 00 per head per month for multi-seated room.

Rs. 20.00 per month for a single room.

- 4.05 Fine and re-admi- the general rules of the Departssion fees ment will apply.
- 4.06 Hostel Establish- Rs. 5/- per month ment
- 4.07 Guest Charges: Rs. 3.00 per day for the first three days and Rs. 5/- per day for the subsequent 5 days beyond which no person shall be entertained as a Guest.

(The Guest charges will be collected by the Asst. Warden and remitted in the Hostel office) Note: 4.01 to 4.06 to be collected by the Departments and credited to Hostel Accounts.

5.00 Mess

- 5.01 The inmates of the hostels may run a mess on a dividing basis, by electing a mess secretary, a mess committee and audit committee from among themselves from time to time, under the over-all supervision of the Assistant Warden.
- 5.02 The mess committee is responsible for the safe keeping of the articles supplied by the University for the running of the mess.
- 6.00 Recreation facilities
- 6.01 Limited facilities for indoor and outdoor games are Provided and a few newspapers are subscribed to by the University.

7.00 House - keeping committee

A House keeping committee of the inmates under the leadership of the Hostel Secretary, elected from time to time may ensure clean physical environment and discipline among the inmates.

- 8.00 Vacating the hostel.
- 8.01 The students should complete the Form C and submit the same to the Hostel office, at least, 15 days before the date of vacating the Hostel.
- 8.02 Before receiving the Caution Deposit back, the student should complete the Form B and submit the same to the Hostel Office.

- 8.03 Hostelers may be required to vacate the hostels during the annual vacation for repair and maintenance work of the buildings and furniture.
- 8.04 At the time of fresh admissions to the hostel, all the previous residents shall be required to fill in the Form B for re-registration.
- 8.05 Transfers between rooms or hostels are not permitted; but in special cases requests based on specific reasons may be considered by the Hon. Warden on merits.
- 3.06 The Hon. Warden shall have the authority to transfer a student from one room to another room or from one hostel to another hostel.
- 8.07 The Head of the Department shall intimate the Hostel Office, at least, 15 days in advance the names of students who are to be sent out-of-station for field work or practical training. The resident shall intimate the Assistant Warden in writing the period of his absence for training or field work. During such period, the room shall not be occupied by any other person. If the Assistant Warden is not available in the hostel, the resident shall inform (in writing)) the Hostel Office, the period of absence. Anyone leaving without prior intimation shall be treated as having vacated the hostel without authorisation and re-admission may be made only on the written recommendation of the Head of the Department.

ASSISTANT WARDEN - DUTIES & RESPONSIBILITIES

1. Assistant Warden shall stay in the hostel to which he is appointed.

- 2. He/She shall assist the Hon. Warden in the day-to-day running of the hostel.
- . 3. He shall be primarily responsible for the enforcement of hostel rules and the maintenance of general discipline among the inmates.
 - 4. He shall exercise supervision over all the organised activities of the hostel and especially over the running of the mess.
 - 5. He shall maintain a record of all the inmates of the hostel and will ensure the observance by them of the hostel time-table.
 - 6. He shall maintain a diary of all the activities of and developments in the hostel and bring to the attention of the Hon. Warden any situation warranting his immediate intervention.
 - 7. Assistant Warden may permit occupants to entertain guests on advance payment of guest charges by them and remit the guest charges to the Hostel Office during the next working day.
 - Assistant Warden shall be the custodian of University property including furniture, fittings, utensils and equipments and shall immediately report to the Hon. Warden any damages caused to them.
- 9. Assistant Warden shall make necessary arrangements for the use of hostel telephones wherever provided and collection of telephone charges from the inmates immediately after the use of the phone. The amount thus collected shall be remitted to the Hostel Office during the next working day.

10. He may grant permission to research students to stay late in the Library/Laboratory for their continued work on the specific recommendation of the Head of the Department.

- I. Detailed Plan & Estimates of the Building of School of Engineering Sciences.
- i. The work may be put to tender in three prominent Dailies as per rules.
- ii. The Superintending Engineer, B & R, Alwaye Circle, agreed to issue the rate confirmity certificate shortly after detailed examination of the estimates in the office.
- 1. Terms & Conditions under which works are to be entrusted to the KSCC Ltd.
- 1. New Hostel: The Committee noted that the work of New Hostel had already been tendered with wide publicity and no contractor has come forward to take up the work. The construction is urgent and considerable time lag has already been there due to reasons beyond control since

sanctioning of the work. The student community are eagerly watching the progress of the construction. In the circumstances, Committee feel that it will be in the best interest of the University that this work is entrusted to the KSCC Ltd. based on negotiation. The basis of negotiation was discussed in detail and based on information furnished to the committee, by Superintending Engineer, B & R, Central Circle, State PWD, the Committee recommend that,

- i) The work shall be entrusted based on negotiation with the KSCC if the rate offered is not more than estimate + 95% less cost of materials supplied by the University.
- ii) Provision can be made for advance payments as wellas monthly advance payments based on bills furnished by the KSCC Ltd. Payments made monthly shall be treated as advance payment against bills and shall be adjusted against the bills for each stage.
- as 8. The payment to the KSCC shall be limited to the amount to be fixed for each stage and may be linked with actual measurement/check measurement of the works done at site.
- 2. Extension to the Existing Women's Hostel: Committee noted that this work had already been tendered twice and here was no satisfactory response. In the circumstances and considering the facts detailed above Committee recommend the entrustment of the above work for a negotiated rate of not more than estimate + 59% over the 1980 estimate rates to the KSCC Ltd.

III. Review of Progress of works

It was pointed out that the Director of Industries has intimated that levy cements may not be available to the University for the quarter ending December, 1982. It is, therefore, recommended that.

- 1. Immediate steps be taken to procure atleast 3000 bags of cement from SIDECO, Cochin in order to ensure uninterrupted progress of works.
- 2. The Vice-Chancellor may be requested to appraise the General Manager, SIDECO about the urgent cement requirements of the University in order to expedite sanction of non-levy cement from SIDECO.
- IV. Construction of Administrative Office Block-Discrepancies regarding payments made to the KSCC Ltd;/pointed out by Shri S. C. S. Menon, Member Syndicate.

The Committee examined in detail the note presented by Shri S. C. S. Menon and the explanatory note prepared by the University Office.

- 1. The Committee is endorsing the view expressed by Shri Menon that payment to KSCC Ltd. should be based on measurements checkmeasured by the University Engineering Department.
- 2. The Committee is also of the view that strict instruction shall be given to the KSCC officials concerned that no materials can be taken out of the University Campus without the knowledge and permission of the University Engineer or an official in the University Engineering Department authorised by him for the purpose. Proper registers

for the purpose shall also be maintained by the University Engineering Department for the purpose.

3. It is noted that the payments are effected only for measured quantity of work done and other eligible item as per conditions in the Agreement. The Committee also make note of the fact that whatever may be the claims of the Corporation in terms of Actuals + 20% ' at interim stage the maximum amount payable to them will be limited to the estimated cost of the work + 95% as per agreement. Hence the Committee is of the view that the payments made to the Corporation, are to be viewed as payments made as per agreement already executed and made to a Government undertaking with the good intention of the University to get the work done as quickly as possible. It is also noted that the University is still to settle bills of about 9 lakhs for various works carried out by the KSCC Ltd., Committee also recommend that the limitation clause of estimate + 95% should be adhered to while making final payment.

V. Repairs and Maintenance work

The University Engineer may prepare immediately estimates in respect of such buildings for which no maintenance work has been carried out since the last 3 years on a priority basis.

- VI. Maintenance and Modification in the Marine Sciences Building.
- 1. The University Engineer may be asked to prepare detailed proposals for the modification suggested by the Head, Department of Marine Sciences.
- 2. Necessary ratification works may be immediately done to rectify cracks seen on the walls of the microbiology laboratory of the department as a temporary measure and further developments watched.

Recommendations

I. Proposals to be placed before the State Planning Board.

The Committee recommended that an annexure to the note already prepared and forwarded to the State Planning Board for Plan assistance for the year 1983-'84 (copy enclosed) might be sent to the Planning Board requesting to recommend special assistance for the following items also:-

- 1. Increased allocation for the purchase of books in the Central Library.
- 2. Construction of residential quarters for the non-teaching staff of the University.

II. Proposals to be placed before the Sixth Plan Visiting Committee.

The Committee noted that the Sixth Plan Visiting Committee would be visiting the University during 20-22 January 1983. The Committee also took note of the fact that out of Rs. 75 lakhs allocated by the Commission for the development of the University during the Sixth Plan period. a sum of Rs. 12 lakhs had already been released to the University as basic grant towards purchase of books and equipments and that approval had been received for Rs. 12.5 lakhs as matching share of assistance for the construction of the new hostel for the students. The commission had also given: sanction to fill up all the Fifth Plan spill over posts during the Sixth Plan period making the expenditure in this regard as the first charge on the Sixth Plan allocation. In the light of the above facts, the Committee observed that there would be only a sum of Rs. 2.50 lakhs left for the construction of departmental buildings under plan and a small amount for filling up new teaching posts other than those already advertised. The Committee therefore recommended the following

(a) Buildings

- 1) Priority I be given for the construction of an extension to the Physical Science Building to meet the requirements of space of the Dept of Applied Chemistry
- 2) Special assistance from outside the Sixth Plan allocation be requested for the construction of:
 - i) quarters for the Vice-Chancellor, Pro-Vice-Chancellor, Registrar and the teaching staff.
 - ii) 8 apartments for the stay of the Visiting faculty appointed under the UGC and other schemes.

iii) A non-resident students centre (NRSC) and facilities for indoor and outdoor games.

(b) Staff

Only minimum essential staff required by each department be asked for, for the consideration of the Visiting Committee

(c) Books & Equipments

- i) More allocation be requested for strengthening the Central Library and other central facilities.
- ii) A need-based list of equipments needed by each department be prepared after examining the list of costly equipments already acquired by various departments.
- (d) Request for more number of fellowships and scholarships and some assistance for examination reform work be also placed before the Visiting Team.

Proposal to be placed before the Visiting Committee on MBA by Correspondence

The Committee noted that the UGC Visiting Committee would be coming to the University on January 24, 1983. The Vice-Chancellor informed that the UGC had identified only 5 Schools of Management in India for the implementation of the MBA by Correspondence and ours was one of them. The Committee therefore resolved that all possible efforts should be put in by the University to implement the programme and suggested that the proposed course should be administered jointly by the School of Continuing Education - the academic aspects being taken care of by the School of Management Studies and the administration and Co-ordination by the School of Continuing Education.

The meeting came to an end at 1 p.m.

NOTE TO THE STATE PLANNING BOARD

1.0 Introduction

The University of Cochin was - conceived - and established by the State Government in July 1971 as the Science & Technology University of Kerala. "Development of higher education with particular emphasis on post-graduate studies and research in applied sciences, technology, industry and commerce" is the basic concern of the University as enshrined in the preamble of the Cochin University Act. In spite of the meagre inputs so far given, the University has done well in promoting training and research in several emerging areas of Science & Technology. Most of the Departments/Schools of study and research the University has started since its establishment are in the fields of applied sciences, engineering and technology. These Departments/Schools could not be developed and consolidated because of lack of adequate support from the State Government. It is not known how and why this University which is producing high quality engineers and technologists at under-graduate, post-graduate and doctoral levels is not allocated funds also from the Technical Education Sector of the State Plan. This needs to be investigated. To quote the State Planning Board from its Draft Sixth Plan (1980-85): "...the Cochin University deserves special financial support in view of the modest financial assistance it has received so far and its technological character". The University expects this to happen atleast from now on.

The Chief Minister and the Education Minister who recently visited this University have said that the State Government is determined to develop this University into a top Technological University. An Expert Committee consisting of eminent scientists and technologists of international repute (and on which the State Government was represented through the Education Commissioner, Shri P. K. Umashankar) has recently prepared a plan and a strategy for the further development of this Technological University consistent with its declared objectives. The Report of the Committee is expected shortly. It is informally understood that the Committee has recommended an annual plan input of at least Rs. 125 lakhs from the State Government with corresponding matching grants from the UGC and other sources. The Committee is also reported to have recommended that in order to reflect its true character, the University be renamed as "Kerala University of Science & Technology, Cochin" or "Science and Technology University of Kerala, Cochin.

2.0 ANNUAL PLAN 1983-84

2.1 Establishment of a Computer Centre

The University is already offering a post_graduate programme in Operations Research and Computer Applications. To offer this programme as well as to implement the large number of sponsored research projects, the University is now buying time from other Computer Centres situated far away. The University has also taken action to start with immediate effect an M. Tech programme in Computer and information Sciences as recommended by the All India Council for Technical Education, Government of India.

A project proposal for the establishment of a major Computer System (VAX - 11/780 Computer) has already

been submitted to the UGC. The esteemed non-recurring cost towards the purchase of the computer and its accessories is Rs. 101.68 lakhs, and the annual recurring expenditure. towards maintenance, salary of staff etc. is Rs. 6 02 lakhs The. R & D organisations and industrial establishments in and around Cochin have shown keen interest in this proposal. It is hoped that the UGC will clear the project provided the State Government extends necessary matching assistance for the building, airconditioning etc.

Minimum matching assistance required for 1983-84 from Rs. 20 lakhs State Government

2.2 Introduction of M. Tech Degree Course in Electronics & Communication Systems and Computer & Information Sciences.

The Visiting Committee appointed jointly by the UGC and the All India Council for Technical Ecucation (Government of India) to examine the development proposals of the Department of Electronics has strongly recommended immediate introduction of an M. Tech Degree course in Computer & Information Sciences in addition to the existing M. Tech programme in Electronics & Communication Systems. The Visiting Committee has recommended to the UGC that a sum of Rs. 59.25 lakhs towards non-recurring and Rs. 8.03 lakhs towards recurring items of expenditure may be made available to the University during the Sixth Plan period for the development of the Electronics Department. Matching provisions will have to be given by the State Government.

Minimum matching assistance required for 1983-84 from State Government

Rs. 20.50 lakhs

2.3 Construction of an Engineering & Technology Block (School of Engineering Sciences)

The University Grants Commission has approved the plan and estimates submitted by the University for the construction of a building to house the Department of Polymer Science & Rubber Technology, School of Technology and the other divisions of Engineering and Technology proposed to be started during the Sixth Plan period. The estimated cost of this building is Rs. 25 lakhs according to the 1981 schedule of rates and the UGC has agreed to pay Rs. 12.5 lakhs for this purpose. According to the present (1981) schedule of rates, the cost of this building will be not less than Rs. 35 lakhs. The balance amount of Rs. 22.50 lakhs will have to be met from the State Plan funds.

2.4 Construction of a hostel for men students and a laboratory building for housing the newly acquired equipments of the Engineering/Technology Departments

The UGC has approved the construction of a new hostel for men students at an estimated cost of Rs. 25 lakhs. The foundation stone was laid recently by the Education Minister and the construction work has been taken up. The work is expected to be completed during 1983-84. The assistance from UGC is 50% and the balance cost of construction has to be met as matching grant.

The Department of Polymer Science and Rubber Technology though started in 1972 has been functioning without

any laboratory facilities of its own. The State Committee on Science & Technology recently granted Rs. five lakks for organising a laboratory. These equipments have to be housed as a matter of urgency. Some sophisticated equipments donated by the Alexander von Humboldt Foundation of West Germany are also on the way. To install these as well as the equipments recently acquired by the School of Technology, the construction of a laboratory building at an estimated cost of Rs. 8 lakks has been taken up on an urgent basis. It is expected to be completed early during 1983-84.

2.5 Consolidation of existing Departments

The Departments/Schools of Industrial Fisheries, Polymer Science and Rubber Technology, Environmental Studies and Technology have been functioning without adequate physical facilities such as buildings, laboratories, equipment etc. Though some such facilities exist in the Departments of Applied Chemistry, Electronics and Ship Technology, they need to be augmented considerably. Substantial capital imputs are required to consolidate these Departments/Schools.

2.6 Modernisation or old Laboratories

Another factor requiring special mention is the necessity to modernise some of the old laboratories of the 44-year old Department of Marine Sciences and the 20-year old Department of Physics. Both these Departments are doing

advanced research in many emerging areas of Science and Technology. They need a lot of modern items of equipment-

3.0 Claim of Cochin University for Funds from Technical Education Sector

As already mentioned, the University of Cochin was conceived and established as a Science & Technology University. This University is producing high quality engineers and technologists at under-graduate, post-graduate and doctoral levels. This University has, therefore, a claim and a right to get funds from the Technical Education Sector.

4.0 The proposed Advanced Centre for studies in Science & Technology

It is understood that there is a proposal to set up in Kerala an Advanced Centre for Studies in Science & Technology. The objectives of the proposed Centre almost entirely tally with the objectives with which the University of Cochin was established 11 years ago. The University of Cochin is already working in many of the areas proposed. Most ideally located in the industrial and commercial hinterland of Kerala, the University of Cochin has developed a pattern of close interaction with a large number of R & D organisations, industrial establishments and Government Departments. Working in many emerging areas of Science & Technology at post-graduate, doctoral and post-doctoral levels, the University has acquired the necessary competence and culture to be declared the Advanced Centre for Studies in Science & Technology. The matter was

represented to the Chief Minister who has agreed to examine this proposal. It is requested that the funds earmarked for the proposed Centre be made available to the University of Cochin. After taking all aspects into consideration, the Expert Committee mentioned above is also reported to have made this recommendation.

5.0 Foreign/External inputs

It is possible to get substantial inputs from the various Departments of the Government of India (ie. Defence, Space, Electronics, Atomic Energy, Science and Technology etc.) as well as from and through various technical collaboration programmes, unesco, US-held rupee funds etc. The University is expecting to get at least Rs. 150 lakhs from these sources during 1983-84. But these funds will be forthcoming - only if - basic infrastructural facilities such as laboratory buildings, basic equipment etc. are provided by the University, for which the minimum Plan inputs required from the State Government for 1983-84 is Rs. 125 lakhs.

6.0 Conclusion

In view of the foregoing, the State Planning Board may kindly recommend to the State Government:

- to provide to the University a Plan allocation of atleast Rs. 125 lakhs for 1983-84 for the programmes/activities mentioned in pars 2.1 to 2.6 as indicated below:

- to allocate to the University adequate funds also from the technical Education Sector to consolidate and further develop the Engineering and Technology Departments of the University.
- to give to this University the funds earmarked for the proposed Advanced Centre of Studies in Science & Technology with a view to further develop the University into a Centre of Excellence in Science and Technology.
