1. In item No. 443.02, the following be added:

"Item No. 443.02: Report of the Committee constituted to study various aspects of granting of recognition and to review the status of research institutions: already recognized by the University.

Appendix I

Report of the Syndicate Sub Committee Constituted for Discussion with the Office Bearers of CUBSA

A sub committee was constituted by the Syndicate in its 439th meeting on 7th July 2001 consisting of Sri Mohammed Ali, MLA, Dr P Rajappan Nair and Dr Babu T Jose to hold discussions with office bearers of CUBSA on a memorandum submitted by them. The first meeting was held on 15.08.2001 by Sri K Mohammed Ali and Dr Babu T Jose. The demands/grievances of B Tech students were discussed broadly and the students were asked to to submit a detailed memorandum spelling out clearly their requirements which were discussed in the next meeting held on 13.09.2001.

The second meeting with office bearers of CUBSA was held on 13.09.2001 where Dr K P Rajappan Nair and Dr Babu T Jose held discussions with CUBSA office bears in the Syndicate room at 3 p.m.

The students had brought a memorandum consisting of 21 demands, A copy of their letter is appended. The points are discussed below one by one:

1. Construction of Hostel without delay:

The students requested that construction of hostels for boys and girls may be taken up urgently. The hostel fee structure should be made reasonable. The Parent-Teacher Association should be fully involved to finalise rent etc. of the hostel.

The committee feels that whatever money can be set apart for hostels as one time grant—in—aid for the girls and boys hostel from the funds we have at present may be allocated for the hostel through budget provisions. The buildings may be planned as proposed earlier (300 seated for men and 200 seated for women) But the construction may be planned in stages such that the first stage may be completed with the funds now available. Refundable interest-free deposit and monthly rent may be fixed in consultation with the parents and teachers of B Tech students.

2. University 15% Overhead:

The students requested that overhead charges of 20% collected from students may be reverted to the earlier rate of 15%

Syndicate may decide

3 Canteen: Any new canteen building should be built. Lean to roof may be provided in the front and rear of the present canteen.

The lean to roofs may be provided immediate for which sanction has already been taken by the Engineering Unit. A major canteen building may be constructed and civil engineering division may be requested to provide the plan urgently.

4. Removal of Bank Charges: Students expressed their objection to the bank of &.10/- for every transaction collected by SBT. They pointed to the lack of space in the bank and fact that all students of SOE cemit the fees directly to the bank. They suggested that SBI or any nationalised bank may be requested to open a branch in the campus with working hours suitable to B Tech students.

The Finance Officer may hold discussions with SBT regarding the bank charges of k.10/- Since the Automatic Telling Machine is being provided in the campus by SBI, a branch or pay office of SBI can be opened in the campus, for the convenience of B Tech students.

5. Physical Education Department: The students demanded that a Physical Education Department with staff and equipments should be provided.

The committee feels that a lecturer interested in sports activities may be designated as faculty-in-charge of the physical education activities of School of Engineering. Funds may be made available for arranging coaches from Sports Council for the training of the students. Creating any permanent posts may not be desirable at this stage.

6. New Lab Block for IT and Computer Science: Students pointed out that there are about 460 students in Computer Science/IT divisions and there is no laboratory block for them. Funds should be allotted for this immediately.

Plan of building exclusively for CES/IT divisions has already been prepared by Civil Engineering Division. It is recommended that a sum of Rs.2.5 crores may be set apart for this building in the budget this year itself.

7. Medical Inspection Fee: Students suggested that medical inspection fee should be converted to Group Insurance Scheme and SOE should have a link with a good Hospital nearby.

The suggestion of Group Insurance was made by CES about 2 years back and the Registrar was requested to finalise the details after holding discussions with the Insurance Agencies. The suggestion of the students should be welcomed and the Registrar, Principal, SOE and Director, CES

may be requested to make arrangements for Group Insurance and explore the possibilitie of a tie up with a good hospital nearby.

8. University Union Representation: The students pointed out that there is only one Councillor representing the 2000 and odd students in the University Union. They wanted representation at the rate of one councillor per year per branch.

Syndicate may decide

9. School of Engineering: For the smooth working of the SOE, the Departmental Heads should be given greater freedom and office assistants as given to the University Departments. The six departments may be provided with their on Office staff, funds etc.

COE at present consists of six divisions. This may be restructured to four fill fledged departments as shown telow under the School of Engineering

- (1) Department of Civil Engg. (2) Department of Mechanical Engg. (3) Department of Electrical and Electronics Engg. (4) Department of Computer Science and Information Technology. This will have equitable distribution of faculty. (20 to 25) and students around 500.
- 10. The internet and library timings should be extended from 8.00 p.m. to 8.00 p.m. and necessary staff position may be created.

The Principal, School of Engineering may be requested to extend the present timings of library and internet facility. He may be asked to submit the details of additional posts required for this in library and internet lab.

11. P.T.A may be formed immediately or Rs. 500/- collected May be refunded.

A committee was consituted in a meeting of parents called by former V.C. The Registrat is the convener of the Committee. He may be requested to call a meeting of the committee and initiate action of the request from students.

12. Alumni Association:

As Alumni Association may be informed.

The Principal, School of Engineering/Director, CES may be requested to take action on the request.

13. " new Hus for S.O.E.

A new bus may be procured or run out rent Additional trip may be arranged as per deamnds on rent.

Two official tours may be included in the curriculum. Principal, SOE may be requested to forward proposals:

The Committee met on 18-1-2001, 3.2.2001 and 14.2.2001 and decided to submit an interim report to the Syndicate on 17.2.2001.

The committee examined the data pertaining to the number of examinations, number of candidates appearing for each examination and present staff strength of the examination wing, which are given as appendix. A detailed statement of the income and expenditure from the Finance Section is awaited before finalising the report. Separate discussions were made with:

- 1. The Joint Registrar (Exams)
- The Deputy Registrar's (Exams),
- Assistant Registrar's (Exams)
- Section Officers (Exams)
- Cochin University Employees Association represented by Sri. Johney Basil and Sri. M. A. Aboobaker
- Cochin University Employees Union represented by Sri.G.Chandradath and Sri.M.D.Peethambaran. 6.

The written representations given by the three Deputy Registrars and the Employees organisations were also discussed. The following are the preliminary observations and the interim recommendations.

I Lagging of Examinations

Eventhough there is an examination calender for the University it could not be followed strictly due to several reasons such as

- the semesters for all the courses do not commence simultaneously or end at the same time.
- Examinations have to be postponed several times based
 - i) requests from students for reasons such as arts festival, sports meet, demands for more time for preparation etc.
 - ii) non-submission of internal assessment marks in time.

Recommendations:

i) Admissions are to be centralised and classes are to be started on same date. P.G. Admissions are to be completed by August and B.Tech admissions by September. Classes für B. Tech should commence in November.

- ii) A panel of Guest Lecturers is to be prepared by the Department Council and got approved by the Vice-Chancellor before July every year. Taking into consideration the workload, sanction should be obtained regarding their appointment prior to the commencement of the classes.
- iii) The Heads of Departments shall be directed to submit internal marks at least 10 days before the commencement of Examinations after completing all the formalities. Examination is part of duty and dereliction of duty shall attract disciplinary actions. Instances where a faculty member fails to give internal marks in time shall be brought to the notice of the Vice-Chancellor by the Head of the Department.
- iv) An Academic Calendar which includes dates of examination is to be prepared. This should be prepared taking into consideration all extra curricular activities. Examinations should be scheduled strictly according to the Calendar. In invariale circumstances such as natural calamities, hartal, etc, the Controller of Examinations shall reschedule the examination with the concurrence of the Pro-Vice-Chancellor. Other requests for postponement shall be entertained only with the permission of the Syndicate.
- v) For post Graduate Examinations the Controller of Exams shall sent the list of examiners to the Head of the Departments who shall be entrusted with the workdof distributing the answerbooks to the internal as well as external examiners from the Department under intimation to the Controller of Examinations.

II. Shortage of Examiners/Setters

The panel of examiners submitted by some Board of Studies has become obselete in many cases. Some examiners including the faculty of Cochin University of Science and Technology itself are hesitating to take up examination duties assigned to them.

Recommendation:

- i) The Board of Studies should update the panel of examiners every year. The panel should contain a minimum of 10 examiners for each paper. The Chairman, Board of Studies shoulf vommunicate the list to the Controller of Examinations and he should ensure that the updated list is received before June in every year.
- ii) The Controller of Examinations should report to the Vice-Chancellor the names of faculty of this University who hesitate to take up examination duties for taking necessary action.

:3:

III. The number of examinations:

The number of examinations have increased substantially. This year recognition is given to three new Engineering Colleges and it is anticipated that a number of new Engineering Colleges are also to be given recognition. Further introduction of new courses in the University Departments increases the quantum of work in the P.G. Sections. In view of the above, adequate staff, necessary infrastructure and space are to be provided.

IV Providing a Vehicle for the Exam. Wing.

wing has recently been auctioned. Examination stationery and other materials are to be supplied at various centres spread over the entire state ie., from Vadakara to Pathanamthitta. Also the answerbooks are to be collected from these centres. As such speedy evaluation of answer books shall be accomplished by delivering the same to the examiner and getting it back. The expenses for direct delivery of the scripts will not be high in view of the postal expenses if they are send by registered post. Scrutiny and revaluation are time bound and for this examiners are to be approached urgently. Hiring of private vehicles is not feasible in view of the confidential nature of the work involved.

Recommendation

Steps should be taken to procure a suitable vehicle to the examination wing within three months. For the time being, one of the staff cars shall be deployed to the examination wing.

y Shortage of staff:

The examination wing as a whole of facing acute shortage of staff. At present there are 5 Assistants on daily wages and the leave vacancies in the sections is yet to be filled up. Taking part in the discussions, the officers expressed their views and suggestions for improving the functioning of the wing. In Cochin University of Science and Technology, unlike in other Universities, the valuation and tabulation are done in the tabulation section itself. Also the number of papers for each examination is also high. Bifurcation of sme sections is also necessary.

Recommendation:

For the time being, as an interim arrangement one Assistant shall be provided in the Examination wing.

ii) A norm regarding the ratio of candidates to Assistants is to be made. This shall be finalised and submitted in the final report.

VI. Valuation Camps

A guideline for the conduct of Centralised valuation camps is to be arrived at. Remuneration to the non-teaching star deputed for the camp, the number of days that can be allowed for preparation and winding up of the camp etc., is to be decided upon.

Recommednation:

A norm regarding the conduct of Centralised Valuation Camp shall be submitted in the final report after ascertaining the practice followed in other Universities.

VII. Other recommendation:

- i) Adequate space must be provided to the Examination Wing.
- ii) Staff on daily wages must be replaced by regular staff.

REPORT OF THE STANDING COMMITTEE ON EXAMINATION MATTERS REGARDING THE FUNCTIONING OF THE EXAMINATION WING

The interim report submitted earlier may be accepted as the final onw with the following additions.

I. STAFF PATTERN IN EXAMINATION WING.

(Considering the pattern off work, the Examp. Wing can be seen in 4 headings viz., General, P.G. Examination UGC Examination and Controller's Office).

A.General

1. Examination C Section - The existing C Section has to be bifurcated.

C1-Purchase, preparation and supply of stationary, printing I Section Officer + 1 clerical Assistant+1 Assistant+1 Poen.

- C2 Payment of remuneration, matriculation, recognition, issue of migration Certificte- I Section Officer+ 3 Assistants.
- 2. Examination A Section Ph.D Appointment of examiners and setting of Question papers for undergraduate courses, notification I Section Officer+ 3 Assistants,
- 3. Examination (confidentail Unit) Existing structure and duty + 1 additional Assistant for preparing and communicating confidential mark lists.
- 4. Poens 2 more
- 5. Typist 1 pool officer + 2 Section Officer + 8 typists+ : 1 clerical Assistant for despatch.

B. Bost Graduate Examinations

With the introduction of credit system of evaluation, the PG Examination work will be totally decentralized. Question paper setting, conduct of examination, evaluation, tabulation of marks and finalisation of results will be done in the Departments itself for all semesters except the final semester. Along with the final semester examination, the Examination wing will conduct the verification of marks, preparation and issue of mark sheets and issue of provisional certificate,

Considering the reduction in work, the PG Examination requires only one section with I Section Officer and three assistants - Examination B Section.

The sections D and E shall be dissolved. As the present examination schedule will be over by only 2002 (2000 admission) as ad hoc arrangement section D and E shall Examinations after the completion of the PG Examinations of the 2000 admission. It may also be considered whether all the examinations to be conducted in the PG after July 2001 be decentralized and entrusted with the Departments.

C. Undergraduate Examinations

The Undergraduate Examination ming may be reorganized in the following lines.

- 1. 1 Assistant per 750 candidates
- 2. One section shall contain 1 section Officer and 3 Assistants.
- 3. No assistant post be created for less than 500 candidates. Any such number may be shared by the then existing sections/Assistants.
- 4. No section may be formed with less than 2 Assistants.

D. Controller's Office

The Controller of Examinations Office may be strengthened with one S.O. and one more Assistant and a Steno Typist.

II. VALUATION CAMPS

The centralized valuation camps should be provided with a staff pattern as given below.

- 1. Camp Officer Section Officer
- 2. Assistant Camp Officers upto 5000 2 Assistants
 Above 5000 upto 10000 3 Assistants
 Above 10000 upto 20000 4 Assistants
 Above 20000 candidates 2 camps
- 3. Preparation days One man day per 800 papers
- 4. One Chairman for each semester and one Chief Examiner per each branch/subject.
- 5. Windinp up 2 days
- 6. Poens to be deputed by the C.E after considering the requirement.

Duties

Camp Officer - Along with the over all supervision of the Camp, the Camp Officer shall draw the advance and disburse the TA/DA etc. to the examiners and other personnels appointed for the camp. The advance shall be adjusted with proper vouchers direktly with the Finance/Audit Department.

Assistant Camp Officers - Distribution of answer scripts to examiners and collection of

The same and mark listsafter the valuation.

Assistant Camp Officers
shall start decoding of the register numbers
from the 3rd day onwards
Of the camps. They may assist the Camp Officer
as and when Necessary.

Handling charges to Class IV employees . may be done as is done in other Universities in Kerala.

Selection of Staff to Cam. Staff to the camp may generally be selected from the Undergraduate examination wing. The criteria may be a combination of willingness, seniority and rotation. In special circumstances the C.E. will have the freedom to depute any of the staff from any of the sections in the examination wing for the job.

Conduct of the Camp.

- 1. The Camp shall be started at least 2 days before the starting of the valuation. The maximum number of days that can be taken as preparation days are subject to the provisions given above.
- 2. Separate meeting of all the examiners and Chief examiners for each paper be conducted on the morning session of, starting day of the valuation camp to prepare the answer keys/scheme of valuation to questions. The valuation should be done according to the Keys.
- The decoding of the register numbers should start on the 3rd day of the valuation camp. Marks after decoding should be handed over to the tabulation section immediately after the conclusion of the camp.

Revaluation

The preparation of the answer scripts for the revaluation shall be done in the respective sections where tabulation work has been done. The preparation will include shading/masking of all the marking of the first valuation.

All the requests for a particular semester shall be pooled together and the revaluation shall be done as a valuation camp. The norms for the conduct of the camp has to be adhered in the revaluation camp also.

The appointment of the examiners for revaluation shall be done by section A tself. If the number of requests for revaluation in a particlar subject is lower than the number of papers an examiner can value a day than the revaluation may be done by sending the anser scripts to the examiners by the Controller directly.
