Item No. 493.01 Confirmation of the minutes of the 492<sup>nd</sup> meeting of the Syndicate held on 29.09.2005.

The Syndicate considered the draft minutes of the 492<sup>nd</sup> meeting of the Syndicate held on 29.09.2005 and approved the same with the following emendations:

1. The last paragraph of the first page be modified as follows:-

"Sri.E.M.Najeeb and Dr.K.T.Damodaran had expressed their inability to attend the meeting due to difficulties to reach the University office because of the All India Strike on 29.09.2005 and their request for leave of absence were approved by the Syndicate.

While reviewing the Minutes for confirmation, members were concerned about the delay that is involved in the third correction of minutes, effectively resulting in a 3months delay in implementing decisions taken by the Syndicate. The meeting therefore resolved as follows:-

The confirmation of the minutes be approved in the very next meeting by reading out the corrections and getting the same approved by the Syndicate."

- 2. In page 2 at the end of para 5 of Item no.1. Conferment of Hon. Degree (D.Sc.)

   the words 'cochin University' be modified as 'Cochin University of Science and Technology'.
- 3. In page 4 at the end of first para, between the words 'convened' and 'the', the word 'by' be inserted.
- 4. In Item no.492.01, the following modifications be made:
  - (i) the word 'besides' be deleted from sl.no.2.
  - (ii) the addition mentioned in sl.no.6 (iii) be modified as follows:

"The Vice-Chancellor reported that the tenderer who quoted the lowest rate declined to accept the offer. Under the rules the next two tenderers who made the quotations are to be contacted to ascertain their willingness to accept the work at the lowest rate in the bid."

5. In Item no.492.02, the last sentence of the resolution be modified as follows:

"Questions were allocated to Syndicate members for answering in the Senate."

6. Minutes of Item No.492.05 be modified as follows:

"The Syndicate considered the estimate (the rates are based on 1999 PWD schedule of rates) amounting to Rs.3.20 lakks (including unforeseen items) and the corrected sketch (as required by the Syndicate held on 24.2.2005 vide item no.483.07) for the construction of Compound wall for the balance portion in the School of Engineering Campus near Siberia Hostel in two parts and also the recommendations of the Standing Committees of the Syndicate on Works and Finance and Purchase.

Resolved that the unfinished wall on eastern side of the School of Engineering Campus be got completed. Construction of the wall and gate proposed on the southern side of the School of Engineering (rear side of Labs) need not be taken up. The unfinished portion of the wall on the southern side in front of the Kerala Water Authority gate should be completed. The above works be executed departmentally.

Also resolved that provide barbed wire fencing above the compound wall all round the School of Engineering Campus at a cost of Rs.49,950/-."

7. In Item No.492.09, the resolution be modified as follows:

"Resolved that the matter be deferred for examining the fee structure in other Universities within three months."

- 8. In resolution no.(iii) of Item No.492.20, the words "as advance" be added after the words '(Rupees Forty Two Lakhs)'.
- 9. The resolution in Item No.492.22 be modified as follows:

"Resolved that the request of the Academic Council, to bifurcate the Board of UG Studies in Engineering to Board of UG Studies in Electrical and Allied Branches of Engineering and Board of UG Studies in Mechanical and Allied branches of Engineering, be declined."

- 10. In the resolution (last paragraph) instead of the word 'are' may be deleted and the word 'do' may be added.
- 11. Minutes of Item No.492.23 be modified as follows:

"While discussing the frustrating delay and unhealthy practices of contractors engaged by the University, the Pro-Vice-Chancellor mentioned his experiences in the Kannur University where the CPWD was doing exemplary work.

The meeting authorized the Pro-Vice-Chancellor to contact CPWD and explore the possibility of entrusting the construction of this building without further tendering."

12. The last sentence of the resolution in Item No.492.28 be modified as follows:-

"The Syndicate ratified the action taken by the Vice-Chancellor and decided to include one law expert also in the Advisory Committee."

The Syndicate considered the matter along with the recommendation of the Standing Committee of the Syndicate on Works.

M/s. Palal Corporation, who quoted the lowest rate of 28.8% above estimate declined to accept the work. As per the Syndicate decision dated 29.09.2005 (vide item 492,23) the next two tenderers who quoted the second and third lowest rates were contacted to know their willingness to accept the work for the lowest rate (28.8%). They declined the offer to accept the work at the lowest quoted rate.
