**CONDOLENCE RESOLUTION**

Former Pro-Vice-Chancellor of CUSAT Prof.(Dr.)S. Balaraman passed away on 17.6.2013. The Vice-Chancellor and the Syndicate expressed condolence over the sad demise of Dr. S. Balaraman and joins his family in their sorrow.

At the outset the Syndicate congratulated Prof (Dr.) Poulose Jacob, the new Pro-Vice-Chancellor.

The Vice-Chancellor apprised the Syndicate of his visit to Planning Commission in connection with the up-gradation of CUSAT into Central Institution.

The Syndicate discussed the various issues related to promotion and placement of teachers and the disbursement of arrears of the UGC Scheme 2010 to be paid to teachers.

The members raised their concern over the letter from the Higher Education Department (No.19509/B2/13/H.Edn. Dated 12.6.2013) and the reply sent thereof, which was later withdrawn. The Registrar has conveyed his apology in the matter.

After detailed discussion and examining the various facts, Syndicate confirmed that all the teaching posts created in SoE and CUCEK are posts created by the Syndicate as per the provisions contained in the CUSAT Act and Statutes and are instituted by the Academic Council. Teachers who are appointed in such posts are regular teachers and are eligible to enjoy all benefits enjoyed by any other regular teacher. Since the posts are not sanctioned/approved by the Government, University has not caused any financial commitment to the Government with respect to the appointment of these teachers so far and University has initiated steps for obtaining concurrence from the Government for these posts.

It is also resolved that a detailed reply based on the decision of the Standing Committee of the Syndicate on Staff & Establishment will be sent.

*The Syndicate resolved to implement the promotions/placements of teachers as per clause 6.1.13, 6.1.14 and 6.1.15 of G.O. (P)No.389/2010/H.Edn. dtd. 07.12.2010 to be effected upto 06.12.2010 given in clause 6.1.21 of the said G.O. and in G.O. (Rt.)
